Whereas the Donor is the sole owner of the property described in the Schedule A. annexured herewith.

Whereas the Donor is desirous of settling on Trust moveable property mentioned in Schedule-A. for the purpose of establishing a School for the education and training of young boys, girls as well as adults in educating them and also in educative and vocational pursuits and other objects for the development of their character.

Whereas the Trustees above named are willing to be invested with the ownership of the property mentioned in Schedule -A. for the purpose of carrying out objects of the Donor under the directions set forth hereunder so as to enable the Trustees to prosecute its objective according to directions and wishes of the Donor.

Now it is hereby declared by the Donor as follows :-

1. That the Donor as beneficial owner of the property mentioned in Schedule A hereto conveys, transfer and grants upto the

Trust all and every property mentioned in Schedule-A to have and held the same in Trust for the object of the Trust as described below to be used and appropriated by the Trustees in order to carry on and fulfil the said object in accordance with the direction of the Donor so far as the same shall extend and the Donor hereby relinquishes for all these any claim to or interest to the said property in Schedule-A hereinafter collectively called as subject matter of the Trust are :-

(i) To open, run, continue, educational School, educational and vocational School or institution in healthy institution.

(ii) To engage teachers, professors, instructors and experts of good moral character and conduct able to impart efficiently and economically upto date instructions to pupils and students intellectual and other useful pursuits.

(iii) To establish the Technical educations like engnering, Computer,

(iv) To establish medical college & Hospital and Hostel etc.

(v) To develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of students, pupils and all those connected with the institution so as to make them good citizens.

(vi) To establish, maintain and run a Boarding House and residential institutions for the students, pupils and those connected with the Institution.

(vii) To invest, dispose of, transfer and otherwise deal with the subject of the Trust in such manner as the Trustees should deem fit so as to enable the Trustees to carry on the objects of the Trust effectively.

(viii) To accept donation, grant, pursuists and other of forings and to deal with the same for the purpose of the Trust.

(ix) To charge moderate tutions fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and msintenance of Schools and institution established or about to be established under the Deed.

(x) To train and equip the pupils so as to develop into good, healthy and progressive citizens.

(xi) To promote and inculcate the dignity of labour, the appreciation of intellectual gifts and talents of all kinds.

(xii) To encourage sportman and adventurous spirits in the students and pupils and those others connected with the institution and coming in contact with the School and institution and coming in contact with them to participate in games of skill and prowess.

(xiii) To development beneficiary conduct and a habit to observe the rule of law and self restraint.

(xiv) To bring out, encourage and develop the inventive and research faculties of the students, pupils and teachers, and affort opportunities for research in art, Science educational under takings.

2. That the Trustees may pay out such stipend and Scholarship and on such terms, if any, as the Trustees may deem fit.
3. The Trustees shall manage the subject matter of Trust as economically and with the circumspection as they may jointly at a meeting or by circulation resolve upon.
4. That if any vacancy arises in the Board of Trustees, which consists of 10 Trustees, on account of death, incapacity, persistent neglect of any trustees, the remaining Trustees may coopt any person provided that such Trustee shall be Co-opted by 3/4th majority of the Board of Trustees.
5. That any question arising in the administration of the Trustees shall be decided by the majority of Trustees acting for the time being.
6. That Secretary of Trust shall be elected by Trustees after every three years.
7. That after defraying all necessary expenses incurred in realisation of the income of the subject matter of property of Trust, the balance of the income shall be deposited in any Nationalised Bank, and the Bank account shall be operated by the joint Signatures of the President and the Secretary of the Trust. The Trustees may out of the corpus of subject matter of the Trust spend such money and out of the sale proceeds of any part thereof appropriate such money or part thereof for laying out, erecting and furnishing any building of the School, and institution for incurring any capital expenditure resolved upon the Trustees.
8. That administration of educational, vocational, industrial undertaking, research and School and all other instructions for carrying on the purpose of the Trust shall be superintendence and control of the direction of the Trustees.
9. That if any dispute shall arise among the Trustees in respect of any matter, the same shall be referred for the decision of Trust President, who may decide the dispute on

such material or information be should deem fit but after hearing all the concerned parties.

10. Some words have been typed by mistake and some other words have not been incorporated in the Trust deed dated 5/12/1998 which can not be rectified due to legal complications. Hence the Trust deed dated 5/12/1998 is hereby cancelled.

11. That as long as the Donor shall live and be able to act in the matter, he will remain President of Trust and shall be entitled to preside all meetings of the Trustees, unless Prose-
-cuted to do so by any lawful excuse or by any rule of law. He will also have a casting vote. The Donor has invested the Trustees jointly with himself with the ownership and possession of the subject matter of the Trust who have agreed to accept the Trust. Schedule(A) Donor has contributed Rs. Twenty thousand.

2. Installation/Distribution of Drinking Water Systems such as Ring Well ,Bore Well etc. For the supply of clean drinking water in the hilly region or other parts of the India for The benefit of general public
3. To give financial aid to poor patients for their medical treatment and also to organize Medical camps from time to time at different places for benefit of patients in mass.
4. To give financial aid to poor and deserving people, I.e. aid to widows, handicapped, Aid to poor parents for marriage of their daughter etc. for upliftment of poor section Of Society
5. To distribute free items of necessity for livelihood to poor and needy persons such As distribution of food grains in extreme poverty areas, blankets and woolen clothes etc. to save from acute cold, wheel chairs to handicapped and rickshaw, sewing machine and hand carts etc. to unemployed poor.
